AGE proposes to amend this rule to achieve the following:

1. Replace uses of "representative" with "ombudsman."
2. Reword paragraph (B) to use "shall."
3. Replace uses of "ombudsman registry" with "ombudsman administrative system."
4. Require proof of completion of continuing education only if requested by the SLTCO. [(C)(2)(f)]
5. Allow, in paragraph (E) of this rule, any type of ombudsman to explain extenuating circumstances for not fulfilling continuing education requirements to either the regional program director or the SLTCO.

AGE also proposes to make non-substantive improvements to this rule.
