ODA proposes to amend this rule to achieve the following:

(1) Replace a word ("submit") associated with a requirement for the outdated mode of paperwork and filing in person with "provide."

(2) Replace an occurrence of the future tense with the present tense.

(3) Require the sponsoring agency to maintain nonprofit directors and officers liability insurance.
