- 1. Amend the definitions of "dietitian" and "licensed dietitian" to incorporate the multistate option enacted by Senate Bill 211 (135th GA).
- 2. Define "greatest economic need" and "greatest social need" as required under 45 CFR 1321.9(c)(1)(iv).
- 3. Define "limited basis" as required under 45 CFR 1321.91(a)(5).
- 4. Amend the definition of "nutrition project" to comply with 45 CFR 1321.87(b).
- 5. Define "rural area" as required under 45 CFR 1321.9(c)(2)(viii)(A).
- 6. Replace "ODA" with "AGE," except for the definition of "ODA," which AGE may retain until it replaces all use of the old acronym.
