This rule explains that ODA (1) generally distributes the state's Title III Older Americans Act funds to each PSA according an intrastate funding formula (IFF) and (2) publishes the IFF in an appendix to a specific federally-required state plan on aging.

ODA proposes to rescind this rule and to simultaneously replace it with a new rule of the same number. In doing so, ODA will comply with Senate Bill 9 (134th G.A.) and section 121.95 of the Revised Code by eliminating the regulatory restriction in this rule without adopting it in the proposed new rule.
