This rule that ODA is proposing to amend introduces Chapter 173-38 of the Administrative Code and defines terms used in the chapter. The chapter regulates the Medicaid-funded component of the Assisted Living Program.

ODA is proposing to amend the rule in the following ways:

- 1. ODA is proposing to update references in the rule to reflect the reorganization of sections of the Ohio Revised Code by H.B.59.
- 2. ODA is proposing to replace "ODJFS" with "ODM."
- 3. ODA is proposing to replace the definition for "authorized representative" with the universal definition for all of Medicaid--including the Medicaid waiver programs--that ODM adopted in rule 5160:1-1-55.1 of the Administrative Code.
- 4. ODA is proposing to replace references to ODJFS rules with references to corresponding ODM rules. ODA is proposing to replace references to ODJFS rules with references to corresponding ODM rules. This is because H.B.59 transformed the Medicaid operations inside of ODJFS into a state department of its own.
- 5. ODA is proposing to amend the rule's title to add the name of the program to the beginning of the title.
