This rule introduces Chapter 173-38 of the Administrative Code and defines terms used throughout the chapter.

Compared to the rule this proposed new rule would replace, this proposed new rule incorporates the following changes:

- (1) This proposed new rule no longer defines "JFS07200" and "ODM02399" because ODA proposes to no longer mention those forms in this chapter. ODM launched the Ohio Benefits Long-Term Services and Supports (OBLTSS) system in October, 2017 as the new way for applicants to seek enrollment in LTSS programs such as the Medicaid-funded component of the PASSPORT Program. As a result, ODA proposes to no longer mention these forms in this chapter.
- (2) This proposed new rule replaces the definition of "service plan" with a definition of "person-centered services plan." Also, this proposed new rule no longer includes "goods or" before "services" in the definition.
- (3) This proposed new rule no longer defines forms ODA1115, ODA1116, and ODA1117 because this chapter does not reference those forms.
