Pursuant to section 119.032 of the Revised Code, ODA is reviewing the rules of Chapter 173-40 of the Administrative Code because every agency is required to review each of its rules at least once every five years. ODA is also taking this opportunity to reorganize the rules of Chapter 173-40 of the Administrative Code. As a result, the eligibility criteria that is part of rule 173-40-03 of the Administrative Code, which ODA is proposing to delete from that rule, is simultaneously being transferred to this proposed new rule without any substantial changes to the language that change the function or intent of the eligibility criteria.
