This rule describes the eligibility requirements, as well as the disenrollment and appeals processes for the PASSPORT grandparented eligibility home care program. The rule also establishes requirements for the assessment and reassessment of applicants and enrollees by PASSPORT Administrative Agencies. The rule is being amended to change the terms used to refer to individuals enrolled in the program, to recognize that the Department of Humna Services has been renamed the Department of Job and Family Services, to update the financial eligibility requirements for the program, and to render the rule gender neutral.

PASSPORT Administrative Agencies are required to assess and reassess applicants and consumers enrolled in the program. The costs of these assessments and reassessments differe from PASSPORT Administrative Agency to PASSPORT Administrative Agency, but are reimbursed by the State of Ohio. Individuals applying for enrollement in the program must be certified by a physician that they have an intermediate level of care or a skilled level of care, but this requirement is the result of rules adopted by the Department of Human Services and is only referenced here. The costs of the physicians visit is not reimbursed by the State of Ohio.
