Page 2 Rule Number: **173-44-04**

This rule implements the unified waiting list for the Medicaid-funded components of the Assisted-Living and PASSPORT Programs and also for PACE.

ODA proposed to make the following amendments to this rule:

- (1) Clarify in the title the programs involved.
- (2) Clarify in paragraph (A) to this rule that it's the Medicaid-funded component of the Assisted-Living and PASSPORT Programs to which this rule applies.
- (3) Delete unnecessary usage of "that, "the." and "has" throughout this rule.
- (4) Replace "he or she" with "the individual" throughout this rule.
- (5) Reword paragraph (B)(3) of this rule for clarity.
- (6) Remove the quotations from "('program')" and "('PASSPORT')" in paragraph (C) of this rule.
- (7) Remove references to forms and definitions of forms because ODM launched the Ohio Benefits Long-Term Services and Supports (OBLTSS) system in October, 2017 as the new way for applicants to seek enrollment in LTSS programs such as the Medicaid-funded components of the Assisted-Living and PASSPORT Programs and PACE.
- (8) Delete the unnecessary reference to a federal rule in the definition of "PACE."
