This rule is being proposed for rescission as part of an effort by the Department to distinguish in Chapter 173-6 of the Administrative Code between "rebates" and "discounts" in order to provide clarity to drug manufacturers who seek to integrate their means-tested discount programs with the Golden Buckeye Prescription Drug program.

Rule Content: This rule defines numerous terms used throughout Chapter 173-6 of the Administrative Code.

Proposed Changes: Because the Department's efforts to distinguish between "rebates" and "discounts" would have resulted in more than fifty per cent of the rule being proposed for amendment, the rule is instead being proposed for rescission in accordance with rules adopted by the Legislative Service Commission and a new rule with the same rule number is being adopted in its place.

The proposed new rule will include two new definitions (i.e., "Drug discount" and "Rebate"), and the term "discount" will be deleted from the rule wherever it appears in the phrase "prescription drug discount program".
