The rule is being rescinded pursuant to the requirements of five-year rule review.

Rule 3301-24-10 of the Administrative Code, Alternative educator license, is proposed to be rescinded because its underlying statute, Section 3319.26 of the

Revised Code, has changed significantly with respect to the prescribed requirements for alternative teacher licensure. Section 3319.26 of the Revised Code formerly prescribed requirements for a two year alternative educator license; however, recent changes to the statute replaced the two year alternative educator license with a four year alternative resident educator license and require participation of these license holders in the Ohio Resident Educator Program. The State Board adopted new alternative resident educator license rules for different types of alternative teacher licenses in 2011 pursuant to Section 3319.26 of the Revised Code and subsequently amended the rules in 2013 thereby rendering obsolete Rule 3301-24-10 of the Administrative Code.
