OAC 3301-51-11, Preschool children eligible for special education, is a rule in Ohio Operating Standards for Education of Children with Disabilities that specifically addresses preschool students. Paragraph (G)(4) and the following subparagraphs provide for the age eligibility requirements for a preschool child. Paragraph (G)(4)(b) (ii) was removed to reflect the removal of the requirement to reevaluate a child with disability that is categorized under the development delay disability. The amended legislation raised the age from six to ten, and the reevaluation is no longer required at that time.
