- (A) RSC shall conduct a public hearing for all administrative rules filed in compliance with Chapter 119. of the Revised Code.
- (B) At least thirty days before the public hearing, RSC shall prepare a notice of public hearing. Which which includes all of the following:
 - (1) A statement that it is RSC's intention to propose, amend, or rescind rules.
 - (2) The date, time, and place of the hearing.
 - (3) A general statement of the subject matter to which the proposed <u>rulesrule(s)</u>, <u>amendmentsamendment(s)</u>, or <u>rescissions</u> <u>rescission(s)</u> relate.
 - (4) The reason for proposing, amending, or rescinding the rule(s).
 - (5) A statement that the rule(s) shall be available for review, free of charge, at the office of the RSC administrator executive director.
 - (6) A statement that the notice of the public hearing and/or the full text(s) of the rule(s) is available from the office of the RSC administrator executive director by any person who requests it and pays a fee not to exceed the cost of copying and mailing.
 - (7) A statement that the public hearing shall be conducted in accordance with Chapter 119. of the Revised Code.
- (C) At least thirty days before all public hearings, except for those relating to Chapter 3304:1-21 of the Administrative Code, RSC shall mail, by first-class postal mail or electronic mail, the a notice of public hearing to the following:
 - (1) The RSC consumer advisory council composed of:
 - (a) The BVR advisory committee.
 - (b) The RSC advisory committee on deafness and hard of hearing.
 - (c) The BSVI advisory committee.
 - (d) The personal care assistance/independent living advisory committee.

(2) The executive secretary of the Ohio governor's council on people with disabilities.

- (3) Local consumer advisory council chairs.
- (D) At least thirty days before a public hearing for an administrative rule, which relates to the group's area of interest, RSC shall mail, by first-class postal mail or electronic mail, thea notice of public hearing to the following:
 - (1) The president <u>and executive director</u> of the Ohio association of rehabilitation facilities.
 - (2) The board of the Ohio vendors representative committee.
 - (3) The president of Ohio goodwill association.
- (E) The members of the committees and councils listed in paragraphs (C) and (D) of this rule shall be requested to inform RSC of the mail method (postal or electronic) by which they prefer to receive the notice of public hearing.
- (E)(F) The members of the committees and councils listed in paragraphs (C) and (D) of this rule shall be requested to notify the groups they represent about the public hearing.
- (G) At least thirty days before the public hearing, RSC shall submit the notice of public hearing to the legislative service commission for publication in the register of Ohio.
