The rule also sets forth the procedure for a facility to obtain informal review of deficiencies that were included on a statement of deficiencies and for the facility to request an independent dispute review by a hearing officer if the facility is not satisfied with an informal review by ODH. The rule has been amended to remove twenty-seven regulatory restrictions in accordance with SB9.
