The five-year review of Chapter 3701-84 of the Ohio Administrative Code is due to be completed by May 1, 2017. The Ohio Department of Health is proposing amendment to rule 3701-84-62.

The rule sets forth the personnel and staffing requirements for PICUs including, but not limited to, a board certified medical director, a pediatric intensivist, a licensed physician twenty four hours a day assigned to the PICU, and nursing staff in number to meet the acuity level and needs of the patients served. The rule has been revised to update the education, training, and experience requirements of physician, nursing, and respiratory therapy staff to be reflective of current industry standards and practices. These revisions are based upon the American Academy of Pediatrics recommendations.
