The rule sets forth the personnel and staffing requirements for PICUs including, but not limited to, a board-certified medical director, a pediatric intensivist, a licensed physician twenty-four hours a day assigned to the PICU, and nursing staff in number to meet the acuity level and needs of the patients served. The rule has been revised to make grammatical changes and to clarify that training and orientation must be documented in a nurse's personnel file. Seventeen restrictions have been removed in accordance with SB9.
