ODH has conducted the five-year review of this rule, and is proposing it with amendments.

This rule provides the personnel and staffing requirements for radiation therapy and

stereostatic radiosurgery service providers. For example, the rule requires each service provider to have a radiation oncologist available for direct care on a daily basis; a certified medical physicist; and sufficient number of qualified staff to meet the needs of patients. ODH is proposing to amend the rule to replace the term "therapy technologist" with the current term, "therapist"; to remove outdated citations; and to make general grammatical changes.
