The five-year review of Chapter 3701-84 of the Ohio Administrative Code is due to be completed by May 1, 2017. The Ohio Department of Health is proposing amendment to rule 3701-84-68.

The rule sets forth the personnel and staffing requirements for radiation therapy and/or stereostatic radiosurgery services. These requirements include the service having a medical director that is either a radiation oncologist or a board certified neurosurgeon depending on the type of service provided. The rule has been revised to provide reference to the current certification/training/licensing requirements for medical physicists in Ohio set forth in Chapters 3701:1-67 and 3701:1-58 of the Administrative Code and to clarify that responses to urgent requests should be available twenty-four hours per day seven days a week.
