The Public Health Council has approved the proposal to rescind current rule 3701:1-58-18 and to file a new version of the rule to detail the acceptable education and practical experience requirement for radiation safety officers for radioactive material licenses.

This rule establishes the training requirements for a radiation safety officer for

medical radioactive material licensees. The Public Health Council has approved the proposal to rescind current rule 3701:1-58-18 and to file a new version of the rule to detail the acceptable education and practical experience requirement.
