The Public Health Council has approved the proposal to rescind current rule 3701:1-58-21 and to file this new version to detail the acceptable education and practical experience requirement for experienced radiation safety officers, teletherapy or medical physicists, authorized medical physicists, authorized users, nuclear pharmacists and authorized nuclear pharmacists on a radioactive material licenses.

OAC 3701:1-58-21 establishes the training requirements for experienced radiation safety officers, teletherapy or medical physicists, authorized medical physicists, authorized users, nuclear pharmacists and authorized nuclear pharmacists on a radioactive material license. The Public Health Council has approved the proposal to rescind the current rule and to file a new version to detail the acceptable education and practical experience requirement.
