Current rule 3701:1-58-21 is proposed for rescission and a new rule proposed to reflect the U.S. Nuclear Regulatory Commission's (NRC) new jurisdiction over naturally-occurring or accelerator-produced radioactive material (NARM). This new federal jurisdiction requires Ohio to amend or rescind rules dealing with exempt radioactive material. The NRC retains the sole regulatory authority over the distribution of exempt radioactive material.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

Rule 3701:1-58-21 establishes the training requirements for experienced radiation safety officers, teletherapy or medical physicists, authorized medical physicists, authorized users, nuclear pharmacists and authorized nuclear pharmacists on a radioactive material licenses. Due to the number of changes, ODH is rescinding the current rule and filing a new one that expands on and clarifies the training requirements.
