Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments or changes are proposed to ensure that the Ohio Uniform Food Safety Code continues to conform to the FDA Model Food Code.

This rule sets standards for acidified white rice preparation in food service operations and retail food establishments. Besides minor stylistic corrections, some terminology changes are proposed for clarity. For example, in the first paragraph, "non-potentially hazardous food" is changed to "non-time/temperature controlled for safety food."
