uniform food safety code to be based on the most current version of the FDA model food code.

This rule provides requirements for acidification of white rice in food service operations and retail food establishments. Proposed changes include: removal of regulatory restriction terms "shall" and "require"; (B)(4) remove "targeted pH of 4.1, not to exceed a", remove "of", add "below", remove "4.3", add "4.2"; (C)(1) remove "targeted pH of 4.1, not to exceed a", remove "of", add "below", remove "4.3", add "4.2"; (C)(2) remove "add three-quarter cup of", add "adding enough", remove "in a clear plastic or metal blend cup", add "to submerge the rice sample", remove ".", add ";"; (C)(3) remove ".", add ";"; (C)(4) remove "of", add "below", remove "4.3", add "4.2", remove "or less", remove ".", add "; and"; (D)(1) add "as specified in paragraph (N) of rule 3717-1-03.2 of the Administrative Code"; (D)(2)(b) add "as specified in rule 3717-1-04.5 of the Administrative Code", add "as specified in rule 3717-04.6 of the Administrative Code".
