Ohio Revised Code Section 3717.05 requires the Director of Agriculture and the Public Health Council to base the Ohio Uniform Food Safety Code, which is the statewide standard for food safety in food service operations and retail food establishments, on the most current version of the FDA Model Food Code. These amendments or changes are proposed to ensure that the Ohio Uniform Food Safety Code continues to conform to the FDA Model Food Code.

This rule states that food service operations and retail food establishments in operation prior to March 1, 2001, may continue to use existing facilities and equipment if they meet four pre-conditions. The rule also states conditions which would necessitate replacement of facilities or equipment.
