The requirements of paragraphs (C), (U), and (HH) will be phased out only for sources in Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage, and Summit County. These sources will be required to comply with one of two new CTGs in the future (i.e., rules 3745-21-26 and 3745-21-29 of the Administrative Code). This is discussed further below:

Language is being suggested for addition to the beginning of this paragraph to identify the phasing out of this paragraph for these Counties.

Paragraph (U).

This paragraph identifies VOC requirements for surface coating of miscellaneous metal parts and products. This paragraph will be replaced by new rule 3745-21-26 of the Administrative Code for sources in Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage, and Summit Counties upon the compliance date in the new rule. Language is being suggested for addition to the beginning of this paragraph to identify the phasing out of this paragraph for these Counties.

Paragraph (HH).

This paragraph identifies VOC requirements for surface coating of automotive/transportation and business machine plastic parts. This paragraph will be replaced by new rule 3745-21-26 of the Administrative Code for sources in Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage, and Summit County upon the compliance date for the new rule. Language is being suggested for addition to the beginning of this paragraph to identify the phasing out of this paragraph for these Counties.
