amended as follows:

Ohio EPA is revising paragraph (P)(2) to re-insert the equation and the full definition of term "k". At some time in the past, the equation and part of the definition of term "k" was erroneously removed from the rule.

Ohio EPA is adding reference to appendix C in paragraph (R)(3). Previously, there was no reference to this appendix in OAC rule 3745-21-10.

Ohio EPA is adding an inspection and maintenance plan for catalytic incinerators as paragraph (S). This inspection and maintenance plan is included as an alternative monitoring option for catalytic incinerators. It is referenced by paragraphs (B)(3)(j)(vii), (B)(3)(l)(iii), (B)(4)(b)(iii), and (C)(8)(g) of OAC rule 3745-21-09.
