This rule is being filed as a part of the 5-year review process for OAC Chapter 3745-21.

This rule establishes emission control requirements for wood manufacturing operations. This rule is being amended as follows:

Similar to OAC rule 3745-21-09, Ohio EPA is revising paragraph (H)(1)(b) and (K)(5)(b) to clarify that there are two monitoring and record keeping options for owners or operators using catalytic oxidizers to comply with the rule. Existing paragraph (J)(2) provides the same options for compliance testing. The two options are to monitor and record either: the catalytic oxidizer inlet temperature, outlet temperature and temperature difference; or the catalytic oxidizer inlet temperature and maintain a catalytic oxidizer inspection and maintenance plan.

Ohio EPA is revising paragraph (M)(1)(c) by replacing "the effective date of this rule" with "May 27, 2005 for facilities located in Butler, Clermont, Hamilton, or Warren county or August 25, 2008 for facilities located in Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage, or Summit county". The revisions related to the May 27, 2005 data and counties were missed in prior rule revisions.

Ohio EPA is removing the reference to a permit-to-operate from paragraph (N)(5)(e)(i). A permit-to-operate has been replaced with a permit-to-install and operate.
