This regulation was voted on at a monthly meeting. The rule relaxes the standards required for providing medical care at the race tracks.

Internal agency experts determined that the cost of compliance includes supplies and staffing for the first aid room. The cost of supplying a physician or paramedic and a nurse under the original rule was over \$500 per race day. The amendment will likely cost hundreds of dollars less. The cost of supplies for the first aid room is around \$200. Defibrillators are provided by the Commission. In the event a permit holder violates the rule, the permit holder could be subjected to fines.
