The purpose of this amendment is to clarify that the use of a lammer or sign, as specified in each casino#s Commission-approved internal controls, is also permissible under Ohio law.

The amendment allows for the casinos to use a lammer or sign, while still having the option to use a transfer slip for any transfer between a poker table bank and the poker room bank. The existing language permits the casinos to only use transfer slips.

This rule contains minimum internal control standards for casino gaming. Pursuant to R.C. 3772.08, casino gaming shall only be conducted by licensed casino operators (governed by R.C. 3772.11, 3772.111, and Ohio Adm. Code 3772-4) or by a licensed management company (governed by R.C. 3772.11, 3772.111, and Ohio Adm. Code 3772-4) retained by a licensed casino operator. Further, all gaming-related equipment, supplies, or services must be supplied by a licensed gaming-related vendor, pursuant to R.C. 3772.12, 3772.121 and Ohio Adm. Code 3772-6).
