This rule promotes uniformity in laws, terminology, test methods, and enforcement procedures within the various state programs. Uniformity, particularly with respect to terminology on the law label, balances the rights and responsibilities of industry and the consumer. When generic terms are used to describe filling materials, industry derives a measure of fairness in a competitive market and the consumer is able to shop wisely by comparing like materials.
