Much of the rule's proposed amendments were stylistic in nature, aiming to correct ambiguities in the prior version, as well as to correct obvious logical fallacies given the prior language. Additionally, sanitization was

added to sterilization to improve consistency with language used in Chapter 3713. of the Revised Code.

The rule requires secondhand articles of bedding, stuffed toys, furniture, and other items to be sterilized or sanitized prior to being offered for sale. The costs associated with sterilizing and sanitizing vary depending upon the item being sanitized or sterilized and the method used to sanitize or sterilize said item. The cost, for example, to sanitize a twin-size mattress with an approved sanitizer, such as Microban X-590, is roughly \$1.88.
