Reegarding time limitations for filing: exceptions of paragraph (D)(3) of rule were added; in self-insuring claims, employer-provided treatment by licensed physician was added to reason to toll; on occupational disease (OD) claims, it was added that 6-mo filing after diagnosis, if applicable, can only lengthen the filing limitation; in certain OD claims, the "at least 3-yr period" and "in-state" requirements regarding injurious exposure were removed. Out-dated terminology was updated.
