The bureau is proposing this rule to add flexibility to the primary functions of the P &T committee are to advise the Administrator regarding formulary management, medication prior authorization criteria and bureau policies and procedures related to drug utilization.

The current rule, which requires an equal representation of pharmacists and physicians presents a limitation on the flexibility of the committee's structure. The bureau believes that using less restrictive language regarding committee composition is desirable. This change will afford the bureau the ability to add medical or pharmacy specialists as necessary, in order to tailor the committee to better respond to emerging clinical trends in drug utilization.

The proposed change provides that the P&T committee shall consist of not more than thirteen nor less than five members who shall be licensed physicians and licensed pharmacists. Several additional, minor formatting and organizational changes are also proposed.
