The committee#s recommendations resulted from consideration of current literature, accepted treatment guidelines and best clinical practice as well as FDA and information published by the drug manufactures.

1. Add coverage of two sustained release forms of gabapentin in the Anticonvulsant Drug Class. Those two drugs are Horizant® (gabapentin encarbil) and Gralise® (gabapentin sustained release). These two drugs will be covered by the Bureau after a trial of at least 30 days of the immediate release form of gabapentin has demonstrated unacceptable side effects or systemic allergic reaction (as defined in OAC 4123-6-21 paragraph (J) (1).

2. Add coverage of the drug Stendra® (avanafil) in the Erectile Dysfunction Drug class. The same quantity restrictions will apply to this drug that apply to similar drugs in the class (6 units per 30 days).
