Remove language that limits reimbursement for first fill medication to a period of ten days or less, and add language limiting reimbursement to the quantity limits listed in the appendix to the rule.

Add language which permits more than one drug in the therapeutic drug class antivirals and antibiotics to be reimbursed.

Revise and clarify language requiring prescribers to indicate the first fill prescription is for a work related injury.

Revise the appendix to reflect quantify limits for each medication.
