This rule establishes the fees to be paid by BWC to providers of inpatient hospital services for injured workers. For 2025, BWC is proposing to:

- Maintain the current benefit plan with no changes,
- Adopt Medicare 2025 IPPS rule updates
- o 2.9% increase in the market basket (inflation)
- o Quality and value related program adjustments (pay for performance)
- Adopt a BWC payment adjustment factor (PAF) of 121.0% of the Medicare rate.

The projected impact of the above recommendations will be a 2025 hospital inpatient payment increase of 5.0% over estimated 2024 payments. The recommendations will continue to ensure Ohio's injured workers' access to quality care. Further, these recommendations will allow BWC to maintain a competitive fee schedule with appropriate benefits and quality care being provided to Ohio injured workers.

Given the Medicare methodology has been in use by BWC since 2007, the annual implementation of updates is relatively routine for hospitals and self-insured employers. It is estimated that the time needed for implementation will be less than 10 hours.
