The differences between this rule and the rescinded rule are the addition of definitions of the terms "person" and "trade or business", and changing of the definition of "successor in interest" so that it is consistent with the use of that term in R.C. Section 4141.24, as amended by S.B. 81, and in R.C. Section 4141.48, as enacted by S.B. 81.
