This filing is based on a R.C.119.032 rule review of Ohio Administrative Code Chapter 4501-33. This new rule is proposed to provide clarification of criteria for equipment inspection of salvage motor vehicles.

This rule provides criteria for equipment inspection of salvage motor vehicles. In addition, this rule provides that inspecting employees are to document in the VIN comments portion of the HP106 form for salvage motor vehicles that the vehicle has not been inspected for compliance with federal motor vehicle safety standards and it provides a website for online access to the Ohio Revised Code and the Ohio Administrative Code.
