This rule sets forth the process for an instructor to renew a certification to teach in the motorcycle and safety education program of the Department of Public Safety,

also known as the Motorcycle Ohio (MO) program. Language has been added to paragraph (D)(2) that refers readers to the 2011 "Motorcycle Ohio Policy and Procedure Manual" to find the number of minimum instructor hours that are required to renew a certification to teach and where the manual may be accessed electronically. Additionally, language has been changed in paragraph (E) to reflect changes in the titles of the MO program's motorcycle courses.
