This is to enhance recognition of the term "VIN" and is consistent with the recommendations of the American Association of Motor Vehicle Adminstrators (AAMVA).

Other changes clarify use of the term "vehicle identification number" and its acronym "VIN" via consistent use of "VIN" as recommended by the AAMVA.
