This rule is being filed as a result of a completed R.C. 106.03 periodic rule review. This rule is being proposed for rescission due to LSC's fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text while adding a comparable amount of new text, which also includes provisions from existing rules 4501:1-11-02 and 4501:1-11-03. This rule is simultaneously being proposed as a new rule under the same rule number.

This rule identifies the application for a replacement VIN plate or replacement vehicle parts derivative VIN plates or stickers.
