The rule tells salons how to have safer air inside their facilities. The rule is needed, because the chemical smell from some of the products ordinarily used in salons, especially when a manicuring service is provided, can make those who breathe the fumes quite ill in the short term and have long term serious health consequences.

This rule has been rewritten to make it more understandable and to remove a reference to a rule in another chapter that no longer exists. A properly equipped exhaust system blows the chemicals used in providing services out of the facility and gets fresh air in. This makes the air safer to breathe. This rule requires such equipment.
