(A) was amended by replacing #licensee# with #individual#, adding #for each license the individual intends to renew#, replacing #as authorized by the board# with #as required by the board#, replacing #input the# with #verify the continuing education#, and replacing #biennial renewal# with #licensing period for the license(s) being renewed. These amendments were made for clarity and to comply with the provisions of Am. Sub. S.B. 213.

(B) was added to comply with the provisions of Am. Sub. S.B. 213 and the remainder of the rule was renumbered accordingly.

(E), which was formerly (D), was amended by removing #or classified as inactive#. This amendment was made to comply with the provisions of Am. Sub. S.B. 213.

(F), which was formerly (E), was amended by replacing #managing# with #advanced practice#. This amendment was made to comply with the provisions of Am. Sub. S.B. 213.

(F)(2), which was formerly (E)(2), was amended by changing #complete# to #completing# for grammatical reasons.

(F)(3), which was formerly (F)(3), was amended by replacing #Filing a late fee in the amount of fifteen dollars, a restoration fee in the amount of thirty dollars# with #Filing the following non-refundable fees: a current license renewal fee of forty-five dollars#. This amendment was made for clarity and to comply with the provisions of Am. Sub. S.B. 213.
