The rule proposed under this statutory authority is necessary to facilitate compliance with the provisions in Chapters 4729 and 3719 of the Ohio Revised Code to promote the public's safety and uniformity of care throughout Ohio. Without these regulations, the Ohio State Board of Pharmacy would not be able to ensure that entities that sell dangerous drugs verify that a purchaser is properly licensed to possess those drugs.

Clarifies a recent change in the ORC that requires certain prescriber businesses that were exempt from terminal distributor of dangerous drugs (TDDD) licensure to become licensed if they possess certain drugs on-site. Also, requires TDDDs to check the status of entities if they are providing compounded drugs for in-office administration pursuant to a new OAC section that went into effect on May 1, 2015.
