Specifies the minimum standards for third party logistics providers. The rule is being amended to specify the required information on an application as well as the individuals who are subject to a background check.

Depending on whether the location will be shipping controlled or non-controlled drugs, the annual license cost ranges from \$750 to \$787.50. It also takes approximately one hour to complete the license application. The cost of a background check per officer of the company is: BCI&I - \$22, FBI - \$24, and some agencies may charge a processing fee (e.g. \$5-\$40).
