Establishes the activities certified pharmacy technicians may perform. The rule is amended to clarify that a technician can enter data directly into computerized record keeping system and adds remote order entry as an activity a certified pharmacy technician may perform.

This rule references the United States Pharmacopeia (U.S.P.) and the Ohio Administrative Code (O.A.C.). The U.S.P. is a generally accepted industry standard for compounding drugs. The U.S.P. and the O.A.C. are generally available in libraries and on the internet to persons who reasonably can be expected to be affected by the rule. U.S.P. is also a required reference for compounding pharmacies.

Violation of the rule may result in administrative licensure discipline for a pharmacy technician. Discipline might include reprimand, suspension of a license, required course work, monetary penalty and/or revocation of a license.

There is no monetary cost to submit a change of contact information to the Board. However, the process will require the submission of a form that may take an estimated five minutes to complete. This is unchanged from the current rule's requirements.
