6. **What are the reasons for proposing the rule?**

This rule is being proposed to amend pharmacy technician standards. Without this regulation, the State of Ohio Board of Pharmacy would not be able to provide uniform requirements for pharmacy technicians.

Establishes the activities certified pharmacy technicians may perform. Amended to include stocking automated drug dispensing units and adds certain requirements for verbal refill authorizations

This rule references the United States Pharmacopeia (U.S.P.), which is a generally accepted industry standard for compounding drugs. An employer that engages in non-sterile compounding will have to provide additional training for certified technicians prior to engaging in non-sterile compounding.

An employer that engages in sterile compounding will have to provide additional training for certified technicians prior to engaging in sterile compounding.

An employer that works with hazardous drugs will have to provide additional training for certified technicians prior to engaging in the handling of those drugs.

If not already developed, pharmacies will incur added costs to develop these trainings.

Requires completion of compounding training before engaging in drug compounding. Requires completion of hazardous drug handling training before handling hazardous drugs.

Violation of the rule may result in administrative licensure discipline for a location licensed as or applying to be a terminal distributor of dangerous drugs. Discipline might include reprimand, suspension of a license, required course work, monetary penalty and/or revocation/denial of a license.
