Specifies the procedure for discontinuing as a terminal distributor which requires the distributor to file a notice with the board. The terminal distributor will need to complete an inventory of all controlled substances being transferred or disposed of.

Requires a terminal distributor of dangerous drugs to notify the board of discontinuation of business. A discontinuation of business form is two pages and takes approximately 10 minutes to complete. The licensee must also submit a complete inventory of all controlled substances being transferred or disposed of and keep records of purchase and dispensing for three years. The inventory may take several

hours to complete depending on the size of the controlled substance stock. It should be noted that maintaining records pertaining to controlled substances for three years is required by the Ohio Revised Code (3719.07).
