Specifies the Ohio requirements that must be followed by a nonresident terminal distributor of dangerous drugs selling drugs into the state, including inspection

procedures. Generally prohibits the sale of controlled substances by non-resident, non-pharmacy licensees.

A non-pharmacy, non-resident terminal distributor needs approval by the Board's executive director to sell controlled substances into the state.

Violation of the rule may result in administrative licensure discipline for a location licensed as or applying to be a terminal distributor of dangerous drugs. Discipline might include reprimand, suspension of a license, required course work, monetary penalty and/or revocation/denial of a license.

Requires submission of information upon request as a condition of compliance.
