As originally proposed the rule was amended to add the State Medical Board of Ohio's website address to rule 4730-1-08(B) in order to facilitate access to the required application form. The revisions in Paragraph (B) are made to simplify the rule and remove the incorporation by reference of the prescribed form.

The revision removes the website address. The revision references Section 4730.15 of the Revised Code, which requires that the application be made on a form prescribed by the Medical Board and include such other information as the Medical Board specifies in rule as necessary to process the application. Paragraph (B) is also revised to clarify that items (B)(1) through (11) are necessary to process the application.
